






Sir,

NOTIFICATION

New Delhi, the March, 2021

G.S.R.— The following draft of certain rules, which the Central Government proposes to issue in exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of Botanical Survey of India (Botanical Assistant) Recruitment Rules, 2015, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Botanical Assistant in the Botanical Survey of India under the Ministry of Environment, Forest and Climate Change.

Any person interested in making any objection or suggestion on the said draft rules may forward the same in writing for consideration of the Government within a period of thirty (30) days to the Director, Botanical Survey of India, Kolkata.

1. Short title and commencement.- (1) These rules may be called the Botanical Survey of India (Botanical Assistant) Recruitment Rules, 2021.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and the pay band, grade pay or pay scale.- The number of posts, its classification and the pay band, grade pay or pay scale attached thereto shall be specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age-limit and qualifications, etc.- The Method of recruitment to the said post, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification- No Person, -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with my person,

shall be eligible for appointment to the said post:

5. Power to relax- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings- Nothing in these rules shall affect reservations, relaxations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
