ORDER

In pursuance of the recommendation of the Departmental Peer Review Committee (DPRC) of MOEF&CC for promotion to the next higher grade under Flexible Complementing Scheme (FCS), for eligible meritorious scientists (BSI) with following existing Rule 12(5) already due **as on 01.07.2024**, the following Group 'A' Scientist of BSI is *in-situ* promoted **with effect from 30th December, 2024** by Hon'ble Minister EF&CC as per Ministry of Environment, Forest and Climate Change Scientific Group 'A' Posts Recruitment Rules, 2015 and provisions of RFCS in officiating capacity to the post with pay scale and pay level of the pay matrix as recommended by the said committee shown against the concerned promotee.
