Scientists of BSI reported **two novel plant species as new to Science** *viz. Russula ashihoi* K. Das, A. Ghosh, Buyck & Hembrom and *Russula indonigra* A. Ghosh, K. Das, Buyck & Hembrom from the Indian Himalaya. Besides, **two legume species** *viz. Crotalaria verrucosa* L.and *Senna auriculata* (L.) Roxb. have also been reported as new additions to the flora of Andaman & Nicobar Islands. During this month BSI signed a MoU with Institute of Bioresources and Sustainable Development (IBSD), Imphal, Manipur at BSI headquarter, Kolkata on 20.11.2020 for scientific cooperation and exchange of scientific knowledge.
