In reply to OM no. 24011/08/2019 – GC dtd. 25.03.2019 regarding monthly DO letter from Secretary (E & F) to the Cabinet Secretary, I am furnishing herewith the following major achievements of Botanical Survey of India for the month of **August, 2020**.

Department: Botanical Survey of India

1. Important policy decisions taken, major achievements during the month:

Scientists of BSI reported **1 novel plant species new to science** viz. *Dendrophthoe gamblei* (Loranthaceae) from the Peninsular India. Besides, they also reported **18 plant species** viz. *Gastrochilus affinis* (Orchidaceae), *Tarenna flava* (Rubiaceae), *Polyalthia longipedicellata* (Annonaceae), *Meistera newmanii* (Zingiberaceae), *Ipomoea parasitica* (Convolvulaceae), *Peristylus orbicularis* (Orchidaceae), *Ipomoea parasitica*, *Habenaria reniformis* (Orchidaceae), *Schonefeldia gracilis* (Poaceae), *Arthraxon hispidus* (Poaceae), *Jasminum roxburghianum*, *Kyllinga odorata* subsp. *Cylindrical*, *Lecanthus peduncularis*, *Neanotis calycina*, *Stylosanthes hamata*, *Tylophora fasciculata*, *Tripogon anantaswamianus* and *Tripogon filiformis* (Poaceae) as new additions to various states of India.
