



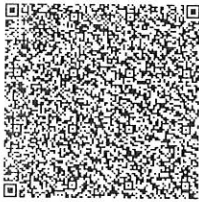

### MEMORANDUM OF UNDERSTANDING

#### CL.1 THE MoU

CL.1.1 THIS MoU made and entered into on this day of June Five Two Thousand Nineteen (2019) A.D. **The President of India**, in exercise of the power vested upon him under article 299 of constitution of India, duly represented on his behalf through **The Director, Botanical Survey of India (BSI), Kolkata** having its head office at CGO Complex, 3<sup>rd</sup> MSO Building DF Block, Sector - 1, Salt Lake City, Kolkata -700064, hereinafter identified and referred as “**BSI**” (which expression, unless repugnant and / or inconsistent to the context thereof shall mean and include his successor in office and assigns) for **THE ONE PART**

**CL.1.2 MANSAROVAR GLOBAL UNIVERSITY, SEHORE** established in 2018 by an Act passed by the MADHYA PRADESH Legislature, having its office at Mansarovar Public School Campus, Kolar Road, Bhopal, Madhya Pradesh 462023 (hereinafter called the **MANSAROVAR GLOBAL UNIVERSITY** which expression shall where the context so admits include its successors and permitted assigns) of the **OTHER Part**.

## **CL.2 PREAMBLE**

Botanical Survey of India (BSI), Kolkata and MANSAROVAR GLOBAL UNIVERSITY, SEHORE has realized the need for a close linkage between the National Laboratories and the Universities in terms of research and academic activities. In compliance to this idea, both have decided to sign a Memorandum of Understanding (MoU) as per the following terms and conditions:

## **CL.3 GENERAL**

**CL.3.1 Botanical Survey of India (BSI)** including all its regional centers, units and Head Quarters all over the country (Arid Zone circle, Jodhpur; Northern Circle, Dehradun; Western Circle, Pune; Southern Circle, Coimbatore; Deccan Circle, Hyderabad; Central circle, Allahabad; Sikkim Himalayan Circle, Gangtok; Eastern Circle, Shillong; Arunachal Pradesh Circle, Itanagar; Howrah; Andaman & Nicobar Regional Centre, Port Blair; Central National Herbarium, Central Botanical Laboratory, Industrial Section in Indian Museums, Botanical Gardens under the BSI, ENVIS Centre) Scientists may participate in the teaching program in the Area of Plant Biotechnology, Botany, Chemistry, Microbiology, Biochemistry, Forestry, and Pharmacy, Environmental Sciences etc. of MANSAROVAR GLOBAL UNIVERSITY on request and subject to mutual conveniences of both the parties.

**CL.3.2 Botanical Survey of India (BSI)**, Scientists and faculty members of Departments of Biotechnology, Botany, Chemistry, Microbiology, Biochemistry, Pharmacy, Environmental Science etc. of MANSAROVAR GLOBAL UNIVERSITY will work towards joint research projects thereby mutually using leading research facilities developed/ to be developed at **Botanical Survey of India (BSI)**, and MANSAROVAR GLOBAL UNIVERSITY.

**CL.3.3 MANSAROVAR GLOBAL UNIVERSITY** will recognize and accept Botanical Survey of India (BSI) scientists as Supervisor / Co-Supervisor (as applicable) for Ph.D. degree of MANSAROVAR GLOBAL UNIVERSITY. **One faculty member of the concerned Department shall be Co-Supervisor / Supervisor (as applicable) with the student of Botanical Survey of India (BSI) registered with MANSAROVAR GLOBAL UNIVERSITY.**

Board of studies, MANSAROVAR GLOBAL UNIVERSITY shall decide Supervisor / Co-Supervisor for the students as applicable.

**CL.3.4** The faculty and students of the above mentioned departments (as mentioned at 1.2) of MANSAROVAR GLOBAL UNIVERSITY shall be allowed to use library of **Botanical Survey of India (BSI)**, subject to the prior permission of the Director. Scientists and Ph.D. Students of **Botanical Survey of India (BSI)**, shall likewise be given the library facilities at MANSAROVAR GLOBAL UNIVERSITY with prior permission of competent authority.

## **CL.4 ACADEMIC AND DEVELOPMENT PROGRAMMES**

**CL.4.1** For the mutual benefit of the two institutions i.e. **Botanical Survey of India (BSI)**, and MANSAROVAR GLOBAL UNIVERSITY, there will be exchange of **Botanical Survey of India (BSI)**, scientists and faculty members of the mentioned departments (as mentioned at point 1.2) of MANSAROVAR GLOBAL UNIVERSITY.

CL.4.2 **Botanical Survey of India (BSI)** and **MANSAROVAR GLOBAL UNIVERSITY** scientists/faculty members will help each other in preparing common research programmes.

CL.4.3 While registering **Botanical Survey of India (BSI)**, students for Ph.D. degree in **MANSAROVAR GLOBAL UNIVERSITY**, the ordinance related to Ph.D. degree of **MANSAROVAR GLOBAL UNIVERSITY** will be applicable. The students/researchers of **Botanical Survey of India (BSI)** shall be required to qualify the entrance examination for registration of Ph.D. as per the norms of **MANSAROVAR GLOBAL UNIVERSITY**.

CL.4.4 **Botanical Survey of India (BSI)** and **MANSAROVAR GLOBAL UNIVERSITY** will work closely to generate appropriately trained manpower in the related areas through organization of formal academic curricula, symposia, short term training courses etc.

CL.4.5 **Botanical Survey of India (BSI)**, as a national laboratory provides necessary rigorous training of research methodology, literature survey, computation of data, at par with the course work (one semester training course) required as per UGC norms / ordinances of **MANSAROVAR GLOBAL UNIVERSITY**. Hence, research students of **Botanical Survey of India (BSI)**, will be completing this course at **Botanical Survey of India (BSI)**.

CL.4.6 Honorarium, TA/DA (if applicable) will be provided to the faculty members/ Scientists/ technical staff of **MANSAROVAR GLOBAL UNIVERSITY** and **Botanical Survey of India (BSI)**, as per rule by requesting organizations.

#### **CL.5 DISPUTE RESOLUTION, JURISDICTION AND CHOICE OF LAW:**

CL.5.1 In the event of any dispute/s that may arise in connection with this MoA, the same shall be mutually settled by the Vice-Chancellor of **MANSAROVAR GLOBAL UNIVERSITY** and Director, **Botanical Survey of India**, Kolkata and if could not be settled by that, both the Vice-Chancellor, **Mansarovar Global University**, Sehore and Director, **Botanical Survey of India**, Kolkata shall appoint an arbitrator on mutual consent and the dispute to be solved by arbitration and such process of arbitration shall be guided by the provision of the **Arbitration and Conciliation Act 1996**.

CL.5.2 **Botanical Survey of India (BSI)** would have a liberty to refer, on certain policy related issues for the advice of the Ministry of Environment & Forest and Climate Change, Govt. of India, New Delhi and similarly the **MANSAROVAR GLOBAL UNIVERSITY** would seek the advice of its competent authority or the State Government, if required to bring a consensus of both the parties.

CL.5.3 All disputes relating to this MOA and its terms and conditions or claims arising there from will be subject exclusively to this jurisdiction of court / forums / tribunals at Madhya Pradesh only.

#### **CL.6 DURATION OF MoU**

CL.6.1 This MoU shall be valid for a period of **120 months** from the date of signing. The duration may be extended with the consent of both the parties under mutually agreed terms and conditions.



CL.6.2 It is further agreed that the Vice-Chancellor, MANSAROVAR GLOBAL UNIVERSITY and Director, Botanical Survey of India (BSI), through periodic meetings will monitor the progress of this MoU.

CL.6.3 Any change/ modification/termination as introduced/suggested by the Review Committee (comprising of Vice-Chancellor, Mansarovar Global University and Director, Botanical Survey of India (BSI), will be binding on both the organizations.
